 - a. Rehabilitation for Lake 10.

9. Accept annual disclosure statements for Investment Officer and bookkeeper.
10. Annual Report regarding Post-Issuance Compliance Policy.
11. Adopt Resolution Adopting Covered Applications Policy.
12. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.
13. Operation of District facilities, including
 - a. billings, repairs, and maintenance;
 - b. hearing on termination of water and sewer service to delinquent customers and for rate order violations and authorize termination of service and/or penalties;
 - c. North Fort Bend Water Authority matters, including Water Provider Conservation Program updates; and
 - d. amend Rate Order.
14. Engineering matters, including preparation of plans and specifications, approval of plans and specifications, advertisement for bids, bid review, contract award, Pay Estimates and Change Orders, and acceptance of projects, if appropriate, including:
 - a. Wastewater Treatment Plant;
 - b. Water Plant Expansion;
 - c. Lakemont Stormwater Reuse Pump Station Rehabilitation;
 - d. Maintenance and Capital Improvement Plan; and
 - e. biannual inspection of District facilities.

 - a. Creekside Park at Lakemont.
17. Phase II Small MS4 General Permit and Storm Water Management Plan, including status of compliance, necessary training, public comment, and approval of year 6 annual report and public education materials.
18. Security matters.
19. Review consultant contracts, including consideration and review of current consultant fees and rates.
