3. 2026 Directors Election, including:
 - a. adopt Resolution Designating an Agent of the Secretary of the Board of Directors During the 2026 Board of Directors Election Period;
 - b. authorize Notice of Deadline to File Applications for Place on the Ballot;
 - c. consider use of electronic voting system and authorize notice of exemption;
 - d. set pay for election officials;
 - e. adopt Order Calling Directors Election; and
 - f. authorize Notice of Election.
4. Landscaping, park, and lake matters in the District.
5. Amended Landscape Management Agreement.
6. District security, including:
 - a. approve Agreement with Flock Safety for license plate readers.
7. Tax assessment and collections matters, delinquent tax collections, installment agreements, and payment of tax bills.
8. Approve audit for fiscal year end September 30, 2025.
9. Financial and bookkeeping matters, including payment of bills, review of investments.
10. Accept annual disclosure statements for Investment Officer and bookkeeper.
11. Website and communication matters.
12. Operation of District facilities, including billings, repairs and maintenance, customer correspondence, and water accountability.
13. Hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
14. Approve engineer's report, including:
 - a. deeds, easements, consents to encroachment, requests for service or utility commitment letters;
 - b. consider upgrading inlets at the Fallbrook Detention Facilities;
 - c. Seven Springs Lake bulkhead;

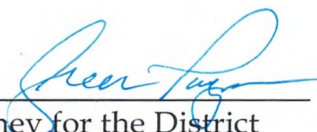
