There will be no separate discussion of these items unless so requested by at least one member of the Board, in which case such item will be removed from consent and considered after action on the remaining consent items:

- 7. Consider approval of amendment to Amended and Restated Agreement for Independent Contractor Services by and among the District and Blue Line Management & Consulting Services, LLC to include engineering services.
- 8. General Manager's report, including Little Elm Police Department and Little Elm Fire Department reports, and authorize actions and expenditures as necessary.

- 9. Engineering matters, including the following items and actions relating to damaged irrigation system and other District projects:

 - b) Approve construction plans and specifications and authorize advertisement for bids;

 - g) Authorize and/or ratify repair and maintenance of District facilities, as necessary.
