11. Development matters, including report regarding development in the District, approval of development financing agreements, amendments to development financing agendas, assignments of development financing agreements, and consents to assignment.
12. Approval of District's insurance renewal policies.
13. Attorney's report.
14. Convene in Executive Session to discuss any of the matters listed above, as authorized by Texas Government Code, Section 551.071 (Consultation with Attorney about Pending or Contemplated Litigation), Section 551.072


