  - c. authorize cancellation of county contract for election services.
9. Engineering matters, including preparation of plans and specifications, approval of plans and specifications, advertisement for bids, bid review, contract award, Pay Estimates and Change Orders, and acceptance of projects.
10. Review and approval of Bond Application Report; and adoption of Resolution Authorizing Application to the Texas Commission on Environmental Quality For Approval of Project and Bond; and authorize issuance of Series 2026 Bond Anticipation Note.
11. Deeds, easements, consents to encroachment, requests for service, utility commitment letters, leases or other acquisitions or dispositions of real property rights.
12. Operation of District facilities, billings, repairs, and maintenance, including hearing on termination of water and sewer service to delinquent customers and authorize termination of service.


