1. Public comments.
2. Approve minutes of prior meetings, including February 17 (Regular), March 3 (Special), March 3 (Greenbelt), and March 9 (Chelford), 2026, meetings.
3. 2026 Directors Election, including:
 - a. accept Certificate Declaring Unopposed Status of Candidates for Election to the Board of Directors; and
 - b. adopt Order Cancelling Election and Declaring Unopposed Candidates Elected to Office.
4. Security services matters, including:
 - a. report from Harris County Sheriff's Office; and
 - b. update on the implementation of signs prohibiting commercial vehicles from parking overnight.

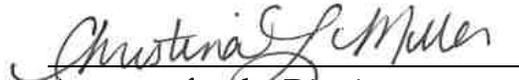
