- 5. Hear Engineer's Report, including:
 - (a) status of construction projects within the District;

 - (d) authorize Engineer to advertise for bids for District projects;
 - (e) authorize construction contracts and related items;

 - (h) consider approval of final plats and amendments to plats;
 - (i) discuss water run-off as observed on Azure Pearl Trail;
- 6. Hear General Manager's Report and authorize any appropriate action and consider approval of any necessary maintenance or other items;
- 7. Hear Triton Consulting Group's Report and authorize any appropriate action;
- 8. Hear Financial Advisor's Report and consider taking any appropriate action;
- 9. Consider matters related to the District's Unlimited Tax Utility Bonds, Series 2025 (the "Bonds"), including:
 - (a) approval of a developer reimbursement audit report for the Bonds;
 - (b) approval of an Amended Notice to Sellers and Purchasers reflecting the issuance of the Bonds and authorize recording of the same in the Collin County Real Property Records;
 - (c) take any actions and execute any necessary documents and certificates for closing on the Bonds; and
- 10. Hear Attorney's Report and consider taking any appropriate action, including any necessary action in connection with the District's Fire Protection Plan Election.
