  - k. allocation of costs for facilities shared with Tradition Municipal Utility District No. 2B of Denton County.
7. Developer's Report, including consent to assignment of receivables.
8. Consent to Sale and Assignment Agreement among SPUR WILDFLOWER DEVELOPMENT, LP, SPUR WILDFLOWER LAND, and UMB Bank, n.a., and approval of the District's Tax Certificate in connection with same.
9. District website and communication matters.
