

## NOTICE OF MEETING


### TRADITION MUNICIPAL UTILITY DISTRICT NO. 2B OF DENTON COUNTY

The Board of Directors of Tradition Municipal Utility District No. 2B of Denton County (the “District”) will hold a regular meeting on **Monday, May 19, 2025, at 12:00 p.m.**, at the offices of Allen Boone Humphries Robinson LLP, 4514 Cole Ave, Suite 1450, Dallas, Texas, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes of previous meeting.
3. Financial and bookkeeping matters, including payment of the bills, and review of investments.
4. Tax assessment and collections matters.
5. Engineering matters, including:
  - a. status of construction projects within the District;
  - b. authorize Engineer to proceed with design of District facilities;
  - c. approve plans and specifications of District facilities;
  - d. authorize Engineer to advertise for bids for District projects;
  - e. authorize construction contracts and related items;
  - f. approve pay estimates and change orders for construction projects in the District;
  - g. consider acceptance of certificates of completion and authorize final acceptance of projects;
  - h. deeds, easements, consents to encroachment, requests for service or utility commitment letters;
  - i. notices of default or other matters related to noncompliance with construction contracts; and
  - j. allocation of costs for facilities shared with Tradition Municipal Utility District No. 1 of Denton County.
6. Status of Application to the Texas Commission on Environmental Quality for Use of Surplus Funds.
7. Discuss surplus funds proceeds.
8. Review supplement to Developer Reimbursement Audit.
9. Developer’s Report, including consent to assignment of receivables.
10. Consent to Sale and Assignment Agreement among Spur Wildflower Development, LP, Spur Wildflower Land, and UMB Bank, n.a., and approval of the District’s Tax Certificate in connection with same.
11. District website and communication matters.
12. Meeting schedule and items for next agenda.
