

NOTICE OF MEETING
DENTON COUNTY FRESH WATER SUPPLY DISTRICT NO. 11-A

The Board of Directors ("Board") of Denton County Fresh Water Supply District No. 11-A will hold a public meeting on **Monday, June 17, 2024, at 6:30 p.m. at 1230 Brendan Drive, Little Elm, Texas**, to discuss and, if appropriate, act upon the following items:

1. Public comment - In accordance with the Open Meetings Act, Directors are prohibited from acting on or discussing any items brought before them at this time. Citizen's comments will be limited to 3 minutes. Comments about any of the agenda items are appreciated by the Board and may be taken into consideration at this time or during that agenda item. Please complete a Public Input Form if you desire to address the Board. All remarks and questions addressed to the Board shall be addressed to the Board as a whole and not to any individual member thereof.
2. Consent Agenda - Items are considered self-explanatory and non-controversial and will be enacted in a single motion. There will be no separate discussion of these items unless so requested by at least one member of the Board, in which case such item will be removed from consent and considered after action on the remaining consent items:
 - a) Approval of Minutes of Board Meeting held May 20, 2024;
 - b) Tax assessment and collections matters as of May 31, 2024; and
 - c) Financial and bookkeeping items, including payment of bills and review of investments.
3. Authorize delinquent tax attorney to proceed with collection of delinquent taxes.
4. Approve annual audit report for fiscal year ended February 29, 2024.
5. General Manager's report; evaluation of replacement and repair needs relative to faulty and/or missing road signage; consider customer utility and trash service billing complaints/requests and appeals; update on Little Elm Police Department; and consider report from FWSD Interlocal/Safety Committee, and the taking of actions appropriate in connection therewith.
6. Discuss and approve the purchase of District security equipment, including Flock camera systems.
7. Review and approve proposed 2024-25 budget for services under Interlocal Cooperation Agreement for Patrol Services.

8. Review and approve proposed 2024-25 budget under Joint Interlocal Agreement for School Resource Officers.
9. Approve Water Conservation Plan annual report and water conservation implementation report.
10. Adopt Resolution adopting amended Drought Contingency Plan.
11. Consider proposals for stormwater management program, including coverage under 2019 TPDES General Permit No. TXR040000, and approve related agreement.
12. Discuss status of District's water and wastewater systems, and authorize actions as necessary.
13. Engineering matters, including the following item and actions relating to, among other projects, pavement failure at 604 Navo Road:
 - a) Design;
 - b) Approve construction plans and specifications and authorize advertisement for bids;
 - c) Review bids and award contract;
 - d) Approve pay estimates, change orders and final acceptance, and direct Engineer to notify insurance company of new facilities;
 - e) Accept certificates of completion and authorize final acceptance of facilities, if necessary;
 - f) Deeds, easements, consents to encroachment, requests for service or utility commitment letters; and
 - g) Authorize and/or ratify repair and maintenance of District facilities, as necessary.
14. Report on District website.
15. Consider status of *City of Aubrey, Texas and Town of Providence Village, Texas v. Denton County Fresh Water Supply District No. 11-A, et al.*, and the taking of action in connection therewith.
16. Consider procedures for bidding new waste collection services contract, and the taking of action in connection therewith.
17. Directors' reports.
