

## NOTICE OF MEETING

### HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 188

The Board of Directors of Harris County Municipal Utility District No. 188 will hold a regular meeting on **Wednesday, June 17, 2026, at 12:00 noon**, at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, on the **24<sup>th</sup> Floor, in the Pecos Conference Room**, Houston, Texas, 77027, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes of prior meetings.
3. Website and communication services and authorize appropriate action.
4. Financial and bookkeeping matters, including payment of the bills and review of investments.
5. Budget for fiscal year end July 31, 2027.
6. Tax assessment and collections matters, including installment agreements, payment of tax bills, placement of aged tax accounts on reserve list, and delinquent tax collections.
7. Authorize delinquent tax attorney to proceed with collection of delinquent taxes.
8. Detention pond improvement matters, including update on erosion repair, drain pipe replacement, and fountain repairs.
9. Storm water quality management matters.
10. Operation of District facilities, including:
  - a. billings, repairs, and maintenance;
  - b. conduct annual review and receive report from operator on Identity Theft Prevention Program and adopt Identity Theft Prevention Program Amendment;
  - c. amend Rate Order, if necessary; and
  - d. update on facility maintenance matters.
11. Hearing on termination of water and sewer service to delinquent customers and authorize termination of service, including discuss delinquent tax accounts.
12. Utility rate study matters.
13. Homeowners Association matters.
14. Discuss security matters, and authorize appropriate action.
15. Copperfield sewage treatment plant operations matters.

16. Engineering matters, including District project and financing information schedule, authorize design, approve plans and specifications, authorize advertisement for bids, review bids and award contracts, approve pay estimates and change orders, authorize final acceptance of projects, and direct engineer to notify insurance company of completed projects, as appropriate, for the following:
  - a. construction of water plant no. 2, including adopt Resolution Expressing Intent to Reimburse;
  - b. lift station no. 1 rehabilitation;
  - c. updated Capital Improvement Plan; and
  - d. deeds, easements, abandonment of easements, and/or consents to encroachment.
17. Annexation and out-of-district service requests.
18. West Harris County Regional Water Authority matters.
19. Meeting schedule and items for inclusion on next agenda.
