  - e. accept certificate of completion and authorize final acceptance of facilities, if necessary;
  - f. deeds, easements, consents to encroachment, requests for service or utility commitment letters; and
  - g. authorize and/or ratify repair and maintenance of District facilities, as necessary.
4. Financial and bookkeeping matters, including payment of bills and review of investments.
5. Tax assessment and collections matters.
6. Authorize delinquent tax attorney to proceed with the collection of delinquent taxes.
7. Approve Audit for fiscal year end February 28, 2026.
8. Review and approve Denton ISD School Resource Officer Budget.
9. Review and approve Little Elm PD Budget.
10. Report on District website and communications and take any appropriate related
