

NOTICE OF MEETING

HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 188

The Board of Directors of Harris County Municipal Utility District No. 188 will hold a regular meeting on **Wednesday, July 15, 2026, at 12:00 noon**, at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, on the **24th Floor, in the Pecos Conference Room**, Houston, Texas, 77027, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes of prior meetings.
3. Authorize auditor to conduct audit for fiscal year end July 31, 2026.
4. Website and communication services and authorize appropriate action.
5. Financial and bookkeeping matters, including payment of the bills and review of investments.

 - a. billings, repairs, and maintenance;
 - b. amend Rate Order, if necessary; and
 - c. update on facility maintenance matters.
12. Hearing on termination of water and sewer service to delinquent customers and authorize termination of service, including discuss delinquent tax accounts.
13. Utility rate study matters.
14. Homeowners Association matters.
15. Discuss security matters, and authorize appropriate action.
16. Copperfield sewage treatment plant operations matters.
17. Engineering matters, including District project and financing information schedule, authorize design, approve plans and specifications, authorize advertisement for bids, review bids and award contracts, approve pay estimates and change orders, authorize final acceptance of projects, and direct engineer to notify insurance company of completed projects, as appropriate, for the following:
 - a. proposal to update GIS system;

- b. construction of water plant no. 2, including adopt Resolution Expressing Intent to Reimburse;
 - c. lift station no. 1 rehabilitation;
 - d. updated Capital Improvement Plan; and
 - e. deeds, easements, abandonment of easements, and/or consents to encroachment.

 - 20. Meeting schedule and items for inclusion on next agenda.
