TRADITION MUNICIPAL UTILITY DISTRICT NO. 2B OF DENTON COUNTY


The Board of Directors of Tradition Municipal Utility District No. 2B of Denton County (the "District") will hold a regular meeting on **Monday, July 21, 2025, at 12:00 p.m.**, at the offices of Allen Boone Humphries Robinson LLP, 4514 Cole Ave, Suite 1450, Dallas, Texas, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes of previous meeting.
3. Financial and bookkeeping matters, including payment of the bills, and review of investments.
4. Approve District's audit report for fiscal year ending April 30, 2025.
5. Tax assessment and collections matters.
6. Adoption of Resolution Regarding Development Status For 2025 Tax Year.
7. Engineering matters, including:
 - a. status of construction projects within the District;
 - b. authorize Engineer to proceed with design of District facilities;
 - c. approve plans and specifications of District facilities;
 - d. authorize Engineer to advertise for bids for District projects;
 - e. authorize construction contracts and related items;
 - f. approve pay estimates and change orders for construction projects in the District;
 - g. consider acceptance of certificates of completion and authorize final acceptance of projects;
 - h. deeds, easements, consents to encroachment, requests for service or utility commitment letters;
 - i. notices of default or other matters related to noncompliance with construction contracts; and
 - j. allocation of costs for facilities shared with Tradition Municipal Utility District No. 1 of Denton County.
8. Review and approval of Bond Application Report No. 1 and Resolution Authorizing Application to Texas Commission on Environmental Quality For Approval of Project and Bonds and authorize the filing of the same.
9. Review Developer Reimbursement Audit and authorize reimbursement to developer in connection with same.
10. Developer's Report, including consent to assignment of receivables.
11. Approval of Amendment to Amended Creation and Operation Agreement for District and City of Fort Worth.
12. District website and communication matters.
13. Convene into Executive Session pursuant to Section 551.072 to discuss Right-of-Way acquisition.
14. Engagement of legal counsel regarding Right-of-Way acquisition.
