

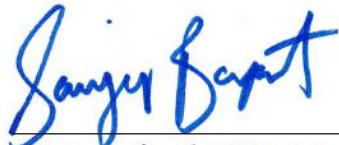
NOTICE OF MEETING

 - d. approval/ratification of advertising for bids for contract(s);

 - h. acceptance of certificate of completion and authorize final acceptance of facilities, amendment of plat(s) and/or easement(s).

7. Tax assessment and collection matters, including delinquent tax collections; special assessment and collection matters, including delinquent special assessment collections.
8. Discuss 2026 Tax Rate, set public hearing date, and authorize Notice of Public Hearing regarding adoption of tax rate.
9. Status Application to the Texas Commission on Environmental Quality for Approval of Project and Bonds.
10. Adopt Resolution Regarding Policies and Rental Procedures.
11. Adopt policy regarding sidewalk rules and regulations.
12. Communications Report.
13. Consider matters for placement on future agendas.
