- 12. Hear Attorney's Report and consider taking any appropriate action, including:
 - (a) conduct a public hearing on the proposed 2025 tax rate;
 - (b) approval of an Order Setting Rate and Levying Tax for 2025;
 - approval of an Amended Notice to Sellers and Purchasers regarding the 2025 tax rate and authorization of filing of the same in the Collin County Real Property Records;
 - (d) approval of a Resolution Evidencing Review of Investment Policy and Investment Strategies; and
 - (e) approval of a Cost Sharing Agreement for Landscaping Project by and between the District and Inspiration Residential Association, Inc.
