

NOTICE OF MEETING

ELLIS COUNTY FRESH WATER SUPPLY DISTRICT NO. 1

The Board of Directors ("Board") of Ellis County Fresh Water Supply District No. 1 (the "District") will hold a regular meeting on **Wednesday, September 23, 2026, at 12:30 p.m., at 10210 N. Central Expressway, Suite 300, Dallas, Texas**, to discuss and, if appropriate, act upon the following items:

1. Public comment – In accordance with the Open Meetings Act, Directors are prohibited from acting on or discussing any items brought before them at this time. Citizen's comments will be limited to 3 minutes. Comments about any of the agenda items are appreciated by the Board and may be taken into consideration at this time or during that agenda item. Please complete a Public Input Form if you desire to address the Board. All remarks and questions addressed to the Board shall be addressed to the Board as a whole and not to any individual member thereof.
2. Approve Minutes of Board meeting held August 26, 2026.
3. Conduct public hearing regarding District's tax rate, adopt Order Levying Taxes, and authorize execution of Amendment to Information Form.
4. Operator's report; address utility service and billing matters, including customer requests, appeals and collections; take any appropriate action.
5. Consider annexation of approximately 6.436 acres into District, including:
 - a) Approve feasibility study;
 - b) Accept Petition for Addition of Certain Land; and
 - c) Authorize execution and filing of Petition for Consent to Annex Land.
6. Developer's report; take any action necessary in connection with reimbursement agreements, consents to assignment, or other development-related items.
7. Engineer's report, including the following items and actions relating to various projects, including offsite storm facilities to serve The Hangout, mass grading of Goodland, Phases 11 and 12, and utility and paving facilities to serve Goodland, Phases 10, 11 and 12:
 - a) Design;
 - b) Approve construction plans and specifications and authorize advertisement for bids;
 - c) Review bids and award contract;
 - d) Approve pay estimates, change orders and final acceptance and, as necessary,

- direct Engineer to notify insurance company of new facility;

 - g) Authorize and/or ratify repair and maintenance of District facilities, as necessary.
8. Financial and bookkeeping matters, including payment of bills and review of investments.
 9. Tax assessment and collections matters.
 10. Approve Annual Report and authorize filing of same, as required by SEC Rule 15c2-12.
 11. Communications and website report, and the taking of any action necessary or appropriate in connection therewith.
 12. Items for placement on future agendas.
 13. Adjourn.
