The Board of Directors ("Board") of Kaufman County Fresh Water Supply District No. 1-C will hold a regular meeting on **Wednesday, September 24, 2025, at 5:00 p.m. at 9558 Helms Trail, Suite 100, Forney, Texas,** to discuss and, if appropriate, act upon the following items:

1. Call to order.
2. Public comments. In accordance with the Open Meetings Act, Directors are prohibited from acting on or discussing any items brought before them at this time. Each citizen's comments will be limited to 3 minutes. Comments regarding any agenda item are appreciated by the Board and may be taken into consideration at this time or during that agenda item. Please complete a Public Input Form if you desire to address the Board. All remarks and questions shall be addressed to the Board as a whole and not to any individual member thereof.
3. Review and approve Minutes of May 28, 2025, August 27, 2025, and September 11, 2025, Board meetings.
4. Consider patrol activity report by Kaufman County Precinct No. 2 Constable's Office, and related action.
5. Review and acceptance of Engineer's report, including the following items and actions relating to, among other projects, application for Public Water System Number; extension of Concord Drive; 2024 Capital Improvement Project repairs; and the District administrative building:
 - a) Design;
 - b) Approve construction plans and specifications and authorize advertisement for bids;
 - c) Review bids and award contract;
 - d) Approve pay estimate, change order and final acceptance and direct Engineer to notify insurance company of new facility;
 - e) Accept certificate of completion and authorize final acceptance of facilities, if necessary;
 - f) Deeds, easements, consents to encroachment, requests for service or utility commitment letters; and
 - g) Authorize and/or ratify repair and maintenance of District facilities, as necessary.

9. Committee matters and reports.
10. Financial and bookkeeping matters, including payment of bills and review of investments.

12. Report on District website and communications and take any appropriate related action.
13. Discuss status of litigation regarding unauthorized use of water on Preston Trail, and take any appropriate related action.
14. Consider matters for placement on future agendas.
15. Adjourn.
