1. Public comment – In accordance with the Open Meetings Act, Directors are prohibited from acting on or discussing any items brought before them at this time. Citizen’s comments will be limited to 3 minutes. Comments about any of the agenda items are appreciated by the Board and may be taken into consideration at this time or during that agenda item. Please complete a Public Input Form if you desire to address the Board. All remarks and questions addressed to the Board shall be addressed to the Board as a whole and not to any individual member thereof;
2. Review and approve Minutes of October 16, 2024, Board meeting.
3. Adopt Order Canvassing Returns and Declaring Results of November 5, 2024, Election Regarding Fire Protection Plan and Interlocal Cooperation Agreement for Fire Protection Services.
4. General Manager's report; evaluation of replacement and repair needs relative to faulty and/or missing road signage; consider customer utility and trash service billing complaints/requests and appeals; update on Little Elm Police Department and City of Aubrey fire services; and consider report from FWSD Interlocal/Safety Committee, and the taking of actions appropriate in connection therewith.
5. Discuss Lead and Copper Service Line Inventory, including approve related notice(s).
6. Engineering matters, including the following items and actions relating to District projects:
  - a. Design;
  - b. Approve construction plans and specifications and authorize advertisement for bids;
  - c. Review bids and award contract;
  - d. Approve pay estimate, change order and final acceptance and direct Engineer to notify insurance company of new facility;
