1. Call to order.
2. Public comments. In accordance with the Open Meetings Act, Directors are prohibited from acting on or discussing any items brought before them at this time. Each citizen's comments will be limited to 3 minutes. Comments regarding any agenda item are appreciated by the Board and may be taken into consideration at this time or during that agenda item. Please complete a Public Input Form if you desire to address the Board. All remarks and questions shall be addressed to the Board as a whole and not to any individual member thereof.
3. Review and approve Minutes of October 23, 2024, Board meeting.
4. Consider patrol activity report by Kaufman County Precinct No. 2 Constable's Office, and related action.
5. Ratify revised October 17, 2024, agreement with Walden Pond Fresh Water Supply District of Kaufman County relative to participation in services under Interlocal Cooperation Agreement for Law Enforcement Patrol Services by and between the District and Kaufman County; discuss expansion of Service Area, increased working-time hours and need for additional officers under said Agreement, and take any action appropriate in connection therewith.
6. Discuss purchase of potential District administrative facility, and take any action appropriate in connection therewith.
7. Consider approval of utility commitment letter relative to storage facility at Irongate Boulevard and Chelsea Lane.
8. Review and acceptance of Engineer's report, including the following items and actions relating to, among other projects, installation of streetlights in Windmill Farms, Phase 2; Reeder Road Section 2 - District Portion extension project; Concord Drive expansion; service to a storage facility; 2024 Capital Improvement Project repairs; and District administrative building:
 - a) Design;

 - g) Authorize and/or ratify repair and maintenance of District facilities, as necessary.
9. Discuss status of application to Texas Commission on Environmental Quality for a public water system number, and take any appropriate actions.
 10. Discuss Lead and Copper Service Line Inventory, including approve related notice(s).
 11. Review and acceptance of Operator's report; address utility service and billing matters, including customer requests, appeals and collections; and take any appropriate related action.
 12. Financial and bookkeeping matters, including payment of bills and review of investments.
 13. Tax assessment and collections matters.
 14. Report on District website.
 15. Committee matters, including committee reports.
 16. Discuss December meeting date.
 17. Consider matters for placement on future agendas.
