- 4. Consider approving an audit report for the District's fiscal year ending August 31, 2024;
- 5. Hear Developer's Report and consider taking any action;
- 6. Hear Engineer's Report, including:
 - (a) status of construction projects within the District;
 - (b) authorize Engineer to proceed with the design of District facilities;
 - (c) approve plans and specifications of District facilities;
 - (d) authorize Engineer to advertise for bids for District projects;
 - (e) authorize construction contracts and related items;
 - approve report, pay estimates, and change orders for construction projects in progress in the District;
 - (g) consider acceptance of certificates of completion and authorize final acceptance of projects;
 - (h) consider approval of final plats and amendments to plats;
- 7. Hear General Manager's Report and authorize any appropriate action and consider approval of any necessary maintenance items;
- 8. Hear Triton Consulting Group's Report and authorize any appropriate action;
- 9. Hear Financial Advisor's Report and consider taking any appropriate action;
- 10. Consider matters related to the District's Unlimited Tax Road Bonds, Series 2025 (the "Bonds"), including:
 - review and approval of a Preliminary Official Statement ("POS") for the Bonds; consider approving Order Distributing POS;
 - (b) authorization of District's Financial Advisor to advertise the sale of the Bonds;
 - (c) authorization of preparation of the developer reimbursement audit report;
 - (d) authorization of District consultants to take any and all other actions necessary to proceed with the issuance of the Bonds; and
- 11. Hear Attorney's Report and consider taking any appropriate action, including approval of an Amended and Restated Order Adopting Policy Regarding Use and Installation of Private Drainage Systems Abutting District Facilities.
