
ROLLING V RANCH WATER CONTROL AND IMPROVEMENT DISTRICT NO. 3 OF WISE COUNTY

The Board of Directors of Rolling V Ranch Water Control and Improvement District No. 3 of Wise County will hold a regular meeting on Friday, December 12, 2025, at 12:30 p.m., at 4001 Maple Avenue, Suite 270, Dallas, Texas, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes.
3. Financial and bookkeeping matters, including payment of the bills and review of investments.
4. Engineering matters, including preparation of plans and specifications, approval of plans and specifications, advertisement for bids, bid review, contract award, Pay Estimates and Change Orders, acceptance of projects, including status of construction of water well field.
5. Ground water supply matters, including:
 - a. Approval of ground water rate study; and
 - b. Approve wholesale raw water supply agreement.
6. Operation of District facilities, including billings, repairs, and maintenance, approval of documents with Central Bank; and status of operational audit.
7. Amendment to approve Professional Services Agreement with Inframark.
8. Deeds, easements, consents to encroachment, requests for service, utility commitment letters, leases or other acquisitions or dispositions of real property rights.
9. West Fork Public Utility Agency Matters, including:
 - a. Order Creating the West Fork Public Utility Agency; and
 - b. Interlocal Cooperation Agreement Regarding Creation and Operation of the West Fork Public Utility Agency.
10. Development matters, including report regarding development in the District, approval of development financing agreements, amendments to development financing agendas, developer sale of receivables, assignments of development financing agreements, and consents to assignment.
11. Attorney's report.
