 - d. installation of smart meters.
13. Engineering matters, including preparation of plans and specifications, approval of plans and specifications, advertisement for bids, bid review, contract award, Pay Estimates and Change Orders, and acceptance of projects, if appropriate, including:
 - a. Lakemont Stormwater Reuse Pump Station Rehabilitation; and
 - b. Maintenance and Capital Improvement Plan.
14. Authorize acceptance and conveyance of easements/deeds/utility deeds, approval of abandonment of easement or facilities, and review of plans.
15. Park project and recreational facility matters, including preparation of plans and specifications, approval of plans and specifications,

advertisement for bids, bid review, contract award, Pay Estimates and Change Orders, and acceptance of projects, if appropriate, including:

- a. Creekside Park at Lakemont.
16. Phase II Small MS4 General Permit and Storm Water Management Plan, including status of compliance, necessary training, and public comment.
