

ORDER SETTING TAX RATE AND LEVYING TAX FOR 2025

WHEREAS, at an election held on November 8, 2011, the Board of Directors (the "Board") of Collin County Water Control and Improvement District No. 3 (the "District") was authorized to levy a maintenance and operations tax by the voters of the District; and

WHEREAS, the District may levy a tax on all taxable property in the District to provide for payment of expenses as set out in Section 49.107, Texas Water Code; and

WHEREAS, at an election held on November 5, 2013, the Board was authorized to issue bonds for road purposes and levy a tax for payment thereof; and

WHEREAS, the District has issued its Unlimited Tax Road Bonds, Series 2015, its Unlimited Tax Road Bonds, Series 2016, its Unlimited Tax Utility Bonds, Series 2017, its Unlimited Tax Road Bonds, Series 2017, its Unlimited Tax Road Bonds, Series 2018, its Unlimited Tax Utility Bonds, Series 2019, its Unlimited Tax Road Bonds, Series 2020; its Unlimited Tax Utility Bonds, Series 2021, its Unlimited Tax Road Bonds, Series 2022, its Unlimited Tax Utility Bonds, Series 2023, its Unlimited Tax Road Bonds, Series 2023, its Unlimited Tax Road Bonds, Series 2025, and its Unlimited Tax Utility Bonds, Series 2025; and

WHEREAS, the tax rolls for the tax year of 2025 have been approved by the Collin Central Appraisal Review Board; and

WHEREAS, the Financial Advisor for the District has made a recommendation as to what the tax rate should be.

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF DIRECTORS OF COLLIN COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NO. 3 THAT:


Section 1: The total tax rate for the year 2025 shall be \$0.8937 per \$100 of assessed valuation; which tax shall be allocated as follows: \$0.2791 per \$100 of assessed valuation for road debt service purposes; \$0.2490 per \$100 of assessed valuation for utility debt service purposes; and \$0.3656 per \$100 of assessed valuation for maintenance and operations tax purposes. The Collin County Tax Assessor/Collector shall take all steps necessary and authorized by law to collect taxes as owed pursuant to this Order. Said taxes shall be levied, assessed and collected at the rate of \$0.8937 per \$100 of assessed valuation for 2025 as provided for in Chapter 49, Texas Water Code, and all other applicable laws.

Section 2: The taxes levied hereby shall be delinquent after January 31, 2026.

Section 3: The President or Vice President is authorized to do all things necessary for execution of this Order; and the President or Vice President is further authorized to execute, and the Assistant Secretary to attest, this Order on behalf of the Board of Directors.
