and all of said persons were present except Director(s) McFarland and Ciarella, thus constituting a quorum. Whereupon, among other business, the following was transacted at the meeting: a written


ORDER CALLING DIRECTORS ELECTION

ORDER CALLING DIRECTORS ELECTION

WHEREAS, the Texas Water Code requires Fort Bend County Municipal Utility District No. 151 (the "District") to hold a directors election on May 2, 2026; Now, Therefore,

BE IT ORDERED BY THE BOARD OF DIRECTORS OF FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 151 THAT:

Section 1: An election is hereby ordered to be held on May 2, 2026, for the purpose of electing two directors to the Board of Directors of the District (the "Board").

Section 2: Written applications for a place on the ballot for the office of director shall be filed at the office of the Secretary of the Board, or the Secretary's authorized agent, by 5:00 P.M. on February 13, 2026.

Section 3: A written declaration of a person's intention to be a write-in candidate on the ballot for the office of director shall be filed at the office of the Secretary of the Board, or the Secretary's authorized agent, by 5:00 P.M. on February 17, 2026.

Section 4: The District will use the regular county election precincts for the election.

Section 5: The District will enter into an interlocal agreement with Fort Bend County (the "County"), by which the County will conduct the election and provide other election services on behalf of the District.

Section 6: The Election Officer of the County shall appoint the presiding judge, clerks, and members of the early voting ballot board for the election.

Section 7: Early voting by personal appearance will be conducted at the locations listed during the dates and hours specified on Exhibit A.

The Board further ratifies and confirms said written notice and the contents and posting thereof.
