Burglary of Motor Vehicle /Rivers Creek Lane- Caller reported their Kia Rio had the back window smashed in overnight. Nothing was taken but the steering column had been tampered with in an attempted theft. Officers located security camera footage and observed the suspect vehicle pass the victim's residence 8 times, stopping once, before driving away. Using FLOCK, Officers identified the suspect vehicle as a silver, Hyundai Elantra (TX TRS2826) registered out of Flower Mound. Surrounding agencies, including Flower Mound, were contacted with suspect information. Flower Mound PD checked the registered residence and did not locate the vehicle. Later in the shift, Richardson PD advised that the vehicle was reported stolen from their agency earlier in the morning. Richardson PD Stolen BOLO stated that the passenger window was broken out of the silver Elantra as well. Later in the shift, the wallet of the victim and another person were found in the front yard of 3133 Manuel Creek Drive, these items were returned to the victims. Report Taken.

INFORMATION REPORT (RECOVERED STOLEN VEHICLE) /MANUEL CREEK DRIVE: Caller reported that her vehicle was entered stolen by Flower Mound PD after her live-in boyfriend left a party in Flower Mound, without her, in a vehicle they traveled to the party in together. The female advised that her boyfriend arrived back at the residence and told her the vehicle was in the neighborhood. Officers located the vehicle in the neighborhood and contacted Flower Mound PD who initially wanted a hold placed on the vehicle but then stated it could be released to the female. Report completed.

WARRANT ARREST DCSO AND LEPD (RACING ON HIGHWAY) /EAST UNIVERSITY DRIVE/Paloma Creek: Related to CFS 25032153. During that CFS, Officer observed two vehicles racing on 380, a Camaro and a motorcycle. During that investigation and follow-up investigations, Officers identified the rider of the motorcycle involved in the race and utilized FLOCK to identify the license plate on the motorcycle. The driver of the motorcycle was found to have a warrant out of DCSO for DWLI w/ Prev. Today, Officers located the motorcycle at 7-11 and observed the rider exit the store to the motorcycle where he was detained. The warrant out of DCSO was confirmed and the rider was transported to DCSO jail. Motorcycle was towed with a hold placed on it. Officers are currently attempting to obtain an arrest warrant for Racing on Highway to be added to the rider's charges at DCSO. Arrest made, report completed.

Warrant Service- University and Navo Rd-Officers conducted a pedestrian stop on an individual for a transportation code violation. A check of the subject showed him to have a warrant for theft out of Dallas County. The warrant was confirmed and the subject was placed under arrest and transported to Denton County Jail. Arrest made.

<u>Indecency with a Child/Water Garden Cir</u>- Officers were dispatched to the location regarding a mother reporting that her 14-year-old daughter had made an outcry of sexual abuse by her father. The mother reported that the child outcried to her father touching her breast, buttocks and attempting to touch her genitals over a period of time. Due to the father living with the child, CID and CPS were notified. **Report taken** 

EDO /Red Robin- Officers were dispatched to the residence in reference to juvenile problems. While on scene, the juvenile attempted to jump out of the window and made suicidal statements. Officers conducted an EDO of the subject and he was taken to Cook Children's Hospital for treatment.

Detention made.

<u>DWI 3rd /Paloma Creek /US 380</u>: Officers were dispatched to an MVA on U.S 380, where Officers observed signs of intoxication on one of the drivers. The officer performed SFSTs and determined that the driver was intoxicated. The driver was placed into custody, and where he consented to a blood draw. The driver was transported to Baylor Scott and White for a blood draw and later to Denton County Jail, where CCH showed two previous DWI convictions. Report Completed / Arrest Made.

Burglary of Motor Vehicle / Shoebill Drive – RP stated an unknown individual entered her vehicle overnight and stole two sets of keys that go to one of her trailers. Report Completed.

<u>Poss CS PG3 & Poss Dangerous Drug / E. University / Navo</u> — Officers conducted a traffic stop for a traffic violation. During the traffic stop investigation, a probable cause search was conducted. During the search, Officers located multiple prescription pills and drug paraphernalia located on a passenger. The pills were found to be Xanax and Trazadone. The passenger was arrested for Possession of a Dangerous Drug and Possession of Controlled Substance PG-3 and transported to the Denton County Jail for booking. **Arrest made.** 

<u>Agg Sexual Assault – Child / New Marion Rd.</u>- RP reported that her 10-year-old granddaughter had been sexually assaulted by a 14-year-old family member. 14-year-old suspect was immediately removed from the home. CID and CPS notified. **Report Taken.**

<u>Theft of a Firearm / Parakeet Dr.-</u> RP reported that her unsupervised children had friends over while she was away at work. RP reported that during this time, her child's friend stole her unsecured and loaded handgun from her bedroom. RP did not have the serial number but wished to file charges against the juvenile suspect who is alleged to attend Braswell High School. Report Taken.

<u>Warrant Arrest Other Agency/Burglary of Habitation /Rockwell Drive</u>- Report of paint, washer, and dryer stolen from this residential new-build some time yesterday. Representative of company found to have a warrant out of DCSO for Aggravated Assault with a Deadly Weapon. Representative completed items for the burglary report and was then taken into custody for his warrant. **Arrest made.** 

<u>DWI/Creekside Dr</u>: Officers were dispatched to a suspicious person's call for service regarding a male banging on the window of a residence. Upon arrival, Officers located the male sitting in the driver's seat of his vehicle, idling on a public roadway showing signs of intoxication. The officer conducted SFSTs on the driver, who was placed into custody for DWI. The driver refused a blood draw, a blood warrant was sought and granted, and the driver was transported to BSW and then to Denton County Jail without incident. **Arrest Made.** 

<u>Traffic Violation / East University Drive/Paloma Creek Dr</u>- Traffic stop for fail to signal turn. Driver was immediately non-compliant with Officer's request to roll down window or exit the vehicle. As Officer attempted to reach in to open the car door, to forcibly remove the driver, the driver rolled the window up on the Officers arm, briefly trapping the Officer's arm in the window. Officer did not feel pain. Officer was able to get his arm free and removed the driver. Driver refused to sign his citation and was taken into custody for the class C violation. Arrest made.

<u>Deceased Person / Hummingbird Drive</u>- Officers dispatched to report of 8-year-old male not conscious, not breathing. Medics arrived with Officers and began life saving measures. Child was transported to Cook Children's Hospital of Prosper where he was declared deceased. Male was involved in a pedestrian versus motor vehicle in 01/2024 (CFS 24018259), which left him dependent on medical equipment for survival. Mother woke this morning to find the male juvenile deceased. She advised she forgot to put on his oxygen sensor before bed last night and did not hear the alarm on his ventilator go off. CID was notified and responded to the residence and the hospital. Report completed.

<u>Criminal Mischief</u> >=\$100<\$750/Jonius Creek Dr. — Officer reported to a call at the location regarding a cracked vehicle window. Contact was made with the reporting party who advised that they had witnessed juveniles shooting BB guns at trash cans in the area. Later they noticed a crack in their vehicle window, which appeared consistent with a BB strike. Report taken.

MV vs. Bicycle / E. university Dr. / Navo Rd. — 11yo was on scooter in PL of establishment. Driver of veh. was in drive through. Child pulled in front of driver as they were pulling out. Driver struck child causing abrasions on leg and foot. Driver did contacted child and made sure was ok. Driver left scene and did not provide any information. Driver was not at location when officers arrived. Child transported to hospital to get checked out. Search of the area did not located driver of motor vehicle. Report completed.

Warrant Arrest, Other Agency / Castle Creek Dr. — Officers responded to the residence for a verbal disturbance between a mother and her adult son. After investigating the disturbance, the son showed to have multiple regional warrants out of Frisco PD and Dallas Marshal's Office. The warrants were confirmed and he was placed under arrest. Arrest made.

<u>Violation of Protective Order /Duck Cove</u>- Officers responded to the residence where a subject was receiving multiple phone calls from a subject that is the respondent on a protected person. Officers confirmed the validity of the protective order. Report taken.

Assault /Ringtail Dr. – RP stated her son was "jumped" yesterday by a single individual. RP has video and pictures of the actor. Report completed.

<u>Criminal Mischief</u> >=\$750<\\$2500 / Golden Eagle Court- The complainant was involved in a road rage incident while traveling on E. University Drive. The complainant advised the other party followed him to his residence on Golden Eagle Court, where she exited her vehicle with a baseball bat. The complainant advised the other party broke one of his car windows and a tail light before leaving the scene. Report completed.

Emergency Detention and Assault CBI FV / Bluebird Drive- Officers were dispatched to the above listed residence for a disturbance. When officers arrived, they determined the residence to be a group home for several special needs individuals. One of the special needs individuals had assaulted two other residents, causing minor injuries. It was discovered that the aggressor in the situation had been transitioning to different medication, which had caused abnormal behaviors and mood swings. In the best interest of everyone involved, the aggressor was transported to Mayhill Behavior Health Center under an emergency detention. Report completed for the ED and Assault.

<u>Duck Cove Dr. / DWI</u>: Officer conducted a traffic stop on a vehicle for a traffic violation. Officer detected signs of impairment, which the driver <u>submitted to SFSTs. Upon completion of SFSTs</u>, the driver was placed into custody for DWI, where the driver provided consent for his blood. The driver was transported to BSW and then to Denton County Jail without incident. **Arrest Made / Report Generated.** 

Runaway Juvenile / Parakeet Drive-Officers were dispatched to the above listed address in reference to a juvenile that had ran away from home. Officers were dispatched to the residence at approximately 0200 hours when the juvenile actually left the residence, but the mother did not want a report completed at the time. At approximately 1649 hours, the mother wanted a report completed so the child was entered into NCIC/TCIC as a runaway. Report completed.

Poss. CS PG 3 <28g /East University Drive and Navo Road-Officer conducted a traffic stop for expired registration near the above listed location. During the course of his investigation, the driver admitted to having contraband in his pocket. A probable cause search of the driver and vehicle were conducted, which revealed even more contraband. A single pill was located in the center console, which was identified as Clonazepam. The driver was arrested for the pill and transported to the Denton County Jail. Arrest/Report completed.

<u>Warrant Arrest (DWI)</u> /North Paloma Creek /Mockingbird Drive- Officer conducted a traffic stop near the above listed location. Officers made contact with the driver and eventually conducted a warrant check of the individual through NCIC/TCIC. It was discovered that the male had an active warrant issued by Gillespie County for Fail to Appear on a DWI Arrest. Dispatch confirmed the warrant and the male was arrested and transported to the Denton County Jail. <u>Arrest completed</u>.

**DWI 3rd/ Paloma Creek & Meadowlark Dr.** Officer observed a vehicle swerving on the roadway and failing to stop at designated points. The officer conducted a traffic stop on the vehicle and made contact with the driver, who showed several signs of intoxication, and the driver admitted to consuming alcoholic beverages. The officer asked the driver to step out of the vehicle to conduct testing, but the driver ignored the officers; after several moments, the driver was removed from the vehicle, and a strong odor of alcohol was detected on him. Officers asked the driver if he would be willing to perform SFSTs, and he stared at the officers. Based on the officer's observations of the driver and his driving behavior, it was determined he was DWI and was placed into custody for DWI 3rd. The driver was taken to BSW, where a blood search warrant was applied and granted. The driver was then transported to Denton County Jail without incident. **Report Taken / Arrest Made.** 

Theft of Property >=\$750<\$2500 /Willet Court- An officer was dispatched to the above listed location. He met with the complainant, who advised several Amazon packages were stolen from the front porch of her residence on 03/17/2025 with an estimated value of \$1,562.20. Report completed

<u>Warrant Arrest /S. Paloma Creek /Mockingbird Dr</u>. - Officer conducted a traffic stop for multiple traffic violations. The driver showed to have an outstanding warrant our of our agency. The driver was taken into custody and transported to the Little Elm Jail without incident. <u>Arrest made.</u>

Information /Paloma Creek Boulevard/E University- FLOCK hit for stolen vehicle out of Addison PD. Vehicle located southbound on South Paloma Creek Blvd. Felony stop completed, locating two females in the vehicle. The passenger was a Braswell High School student and the driver was her grandmother, taking her to school. Investigation found that the vehicle was rented by the adult daughter of the driver, mother of the passenger, and she had not returned the vehicle. Contact with Addison PD Auto Theft Detective who confirmed that the adult daughter was the suspect in the offense. Information for the suspect's whereabouts was gathered from the grandmother and she was given a courtesy transport back to her residence. Braswell student was released to SRO and transported to school. Vehicle towed by LW. Report to be forwarded to Addison PD to further their investigation. Report completed.

Agg Assault SBI / Assault Fam/House Impede Breath / Interference W/Emergency Req for Assistance / Horizon Ridge Cir — Officer responded to the location for a domestic disturbance. Upon arrival, the victim was being transported to THR Frisco. Officers spoke with the victim at THR Frisco who advised that she had been in a verbal altercation with her boyfriend that turned physical. During the altercation, the victim's boyfriend strangled her, then punched her several times in the face causing several fractures on her face. Furthermore, when the victim tried to call 911, the suspect restrained her and tried to slap her phone away from her. The suspect was later located by officers driving home. The suspect was arrested and transported to the Little Elm Jail and then later the Denton County Jail. Arrest made.

Burg of Building /E. University Dr. (Christian Brothers Automotive) — Officers responded to the location for an alarm and were notified by the alarm company that an unknown subject forced entry into the building. Officers learned that the actor had burglarized other Christian Brothers locations and the actor entered the cash register but was unsuccessful in obtaining money or other property. Report made.

Runaway / Kittyhawk Dr. – RP stated 16yo son runaway after she accessed phone and found out son was lying about school and practice. Mother stated son is not suicidal but may have been years ago during COVID. Search of the area did not locate son. Report completed.

Public Intoxication /Ringtail- Officers were dispatched to the listed location in reference to an intoxicated subject that was recently released to a sober party, but had once again left the residence and was yelling in the street. Officers made contact with the subject and determined that he was intoxicated in a public place and a danger to himself and others. Arrest made

Return Runaway / Assault CBI / Kittyhawk- Officers responded to an assist other agency located at 1401 Underwood due to a runaway that was listed by our agency, found at this address wanting to speak with LEPD officers. While interviewing the subject, he complained that he was assaulted by his mother multiple times in the past. CPS was notified and a report was made. After being determined that CPS would not have any further involvement, the runaway was returned to his parents. Report taken.

<u>Warrant arrest /Villa Paloma</u>- Officers made contact with a suspicious vehicle parked in the parking lot of the listed location. Officers ran the occupants and found that one had an outstanding TCIC warrant. <u>Arrest made</u>.

Public Intoxication (Arrest) / Terroristic Threat (Report) / Eppright- Officers were dispatched to the listed location for a disturbance where the husband was intoxicated outside the residence, causing a disturbance with his wife by banging on the front door. Officers determined that the subject was highly intoxicated and had history of family violence. The subject was also reported to have made threats to the wife prior to our arrival. With no one to take responsibility of the subject, he was arrested for Public Intoxication and transported to the Denton County Jail for booking. Arrest made

<u>Violation of Protective Order / Aviary Drive</u> – RP walked in to the PD lobby to report her ex-boyfriend has been continuously sending her text messages and calling her. The RP has an active protective order in place which lists her ex-boyfriend as the respondent. Report taken.

**Death Investigation /Nightingale Drive**- Officers were dispatched to a unconscious person at the above listed address. A male with cancer was found deceased by his wife early this morning. CID was notified. **Report completed.** 

<u>CPS Referral /Eppright Drive</u>- Allegations of sexual abuse after non-verbal special needs juvenile began defecating on themselves at school in recent months. Report taken.

Information Report/Sparrow Ln Officers were dispatched to assist LEFD on an unconscious person CFS; RP reported his father's face was purple and unconscious. Upon the officer's arrival, LEFD had already placed the male subject in the ambulance, where CPR and Narcan were deployed on the father; officers did not observe any illicit drugs in plain view. Officers interviewed the family, including RP, and nobody was aware of a drug history or any narcotics inside the residence. The male was transported to THR in Frisco, where he was stable; while en-route to THR, the male admitted to LEFD that he had used Fentanyl. Officers conducted a follow-up interview, where the male denied Fentanyl usage. Narcotics notified / CPS notified . Report completed.

<u>CPS Referral /Duck Cove Drive</u> – Allegations of physical abuse after juvenile returned to guardian from this residence with injuries. Juvenile also alleged he witnessed his bio mother who lives at this residence, assault his younger brother. Report taken.

Structure Fire/Child Abandon / Whistler- Officers were dispatched to the residence for a structure fire and upon arrival, observed multiple children outside of the residence with two children still inside asleep with the residence filled with smoke. Officers were provided entry to the residence via the children on scene where they evacuated them to a safe area until LEFD arrived. It was found that the children were left alone for approximately one hour while the mother picked up the children's father after being involved in a crash. Due to the youngest child being 2 years old and the oldest being 10, an investigation was conducted, and CPS was notified. Report taken.

<u>Mail Theft / Toucan</u>- Officers responded to the listed residence in reference to a package theft. RP advised that her package was stolen from an unknown B/F. RP wished to press charges. Report made.

<u>DWI /US380 / S. Paloma Creek</u> – Officer made a stop on a vehicle for a moving violation. Contact was made with the driver, who showed signs of intoxication. SFSTs were conducted and the driver was taken into custody. The driver was taken to Baylor Scott and White for a consent blood draw and transported to Denton County Jail without incident. Arrest made.

Information / Adrian Creek Drive- A 2-year-old child was found walking south down the 1000 blk of Rivers Creek Lane by a good samaritan. The mother of the child arrived on scene and advised the child had just walked out of the garage moments earlier after defeating a lock on a door in the house. This was the second time this child had been found walking from this residence. Officers canvassed the area for video footage to confirm how long the child had been away from the residence but the search was inconclusive. Report taken.

Poss CS PG 1<1G/S Paloma Creek Blvd—Traffic stop for Fail to Stop at Designated Place. Driver admitted to having methamphetamine in the center console and advised he purchased it at an area gas station last night. PC search did in fact yield the meth from the center console. Driver placed under arrest and transported to DCSO Jail. Arrest/Report

Agg Assault Deadly Weapon / S Paloma Creek Blvd- While Officers were on the other S Paloma call, Dispatch reported that a female fell out of a lifted truck during a rolling disturbance in this area. A LEPD Street Crimes Detective located the scene immediately and requested medics. The investigation revealed that the female and male were in a dating relationship and were in South Paloma so the male could show the female his new house he just purchased. The male and female got into a verbal argument while leaving and the female began recording the male to show his actual girlfriend that he was cheating on her. The male hit the female and attempted to take her cell phone. The male then opened the door and pushed her out of the vehicle while it was still moving. The female fell from the vehicle and hit her head on the pavement and was dragged for approximately 100 ft. Arrest/Report. Command notified.
